The tenders shall reach to office of Budget & Accounts Assistant of District & Sessions Judge, Mansehra on 27-11-2025 at 10:00 AM, which will be opened on the same day at 11:00 AM in presence of available and interested bidders or their authorized agents. Terms and conditions in detail are also available in bid documents.
2. The offerers/ bidders must be registered with income tax & sales tax and active on tax payer list of FBR and the Registration Certificates must be attached with the bid documents otherwise bid will not be entertained.
3. Each bid shall comprise a single sealed package containing two separate sealed envelopes, marked in bold letters as "**TECHNICAL PROPOSAL**" and "**FINANCIAL PROPOSAL**" respectively. Bidding Procedure shall be followed for procurement of Items under head Computers Items, LED, Water Dispenser, Solar System, and Water Filtration Plant. Moreover, the bidding procedure for procurement of item Stationery and Furniture shall comprise of single sealed envelope and single stage.
4. Quantity of each item in all heads can be increased or decreased as per available budget.
5. All Government Taxes and other deductions will be made as per Rules.
6. Incomplete, ambiguous, conditional bids and those received after due date & time, shall not be accepted.
7. The Competent Authority reserves the right to reject all or any of the bids under KPPRA Acts 2012 and Rules 2014 & 2022.
